Actions you can take this month:

- ✓ Take action to support human rights in Kashmir by signing a new petition here. This sends an email to the Indian High Commissioner in London urging him to ensure human rights are at the heart of democratic government in Jammu & Kashmir. And please join us on 1 August to mark the 5th anniversary of the downgrading of the state to two union territories, ruled directly from Delhi.
- ✓ Use any opportunities you have, in the lead up to the UK's general election, to question our parliamentary candidates about their attitudes to human rights. For example, will they try to protect the UK's Human Rights Act? Will they support the right to protest? Will they back demands for an immediate cease-fire in Gaza? What do they know about the BK16?
- ✓ Mark the 18 July in your diary to come along to our fund-raising AmnesTea at 1500 at Mayhill in Carhampton. Donations for the raffle, book and produce stalls will be very welcome, and do invite your friends to come along and join us!

Our very sad news this month is the death of our wonderful, veteran campaigner and Amnesty supporter, **Philippa Gerry** on 13 May. Philippa was a member of our group from when it started in 2002 and was unfailing in her support for Amnesty and our group's activities. She was an exemplar letter writer, always writing on behalf of all the cases in the AIUK magazine and in the annual Write for Rights Campaign. Last autumn, at the age of 91, she led a

Campaign News

INDIA Cherry writes: In Amnesty's latest State of the World's Human Rights report, misuse of national financial and investigation agencies against civil society, human rights defenders, activists, journalists and critics is highlighted (this is how the Amnesty India office was forced to close). Also noted is that government officials, political leaders, and BJP supporters have advocated hatred and violence against religious minorities with impunity, particularly Muslims, leading to a rise in hate crimes. The campaign group for international civil liberties, Freedom House, says that journalists and others who question the BJP government have increasingly been harassed, and classifies India as only 'partly free'.

BK16: Good news that one of the BK16, Gautam Navlakha (in prison since March 2020) has finally been released on bail. However, he will remain under strict house arrest and have to pay expenses for 'security'!!

Bhopal: In a new report *Bhopal: 40 years of Injustice* published ahead of the 40th anniversary of the Bhopal disaster, Amnesty outlines how the failure of the US-based chemical company, Dow, to provide remedy to victims of a deadly gas leak from a pesticide plant in India that resulted in the deaths of more than 22,000 people, has created a 'sacrifice zone', in which as many as 500,000 people across multiple generations continue to suffer.



Afghanistan – a recommended read: Zarifa: A Woman's Battle in a Man's World by Zarifa Ghafari with Hannah Lucinda Smith. A very readable personal memoir of Zarifa's battle to become Afghanistan's first female mayor, in November 2019. The book gives profound insights into life in Afghanistan. Her courage is astonishing.

New UN Network

Cherry says: I have joined this new initiative, which aims to increase Amnesty's engagement and visibility with the UN, starting with a particular campaign on limiting the use of the veto by the five permanent members of the Security Council in cases of mass atrocities. We have all seen the huge negative impacts of this in stopping resolutions aimed at preventing, or at least mitigating, current horrors such as Gaza and Ukraine, and many more in the past, such as Rwanda. It's a tall order, but there are some impressive people working on this issue, who spoke at the launch webinar.

Other News

British Institute of Human Rights (BIHR): Alison attended an online training event in May about this small independent charity. Its aims are:

- To empower individuals
- To help community groups use a human rights based approach to achieve their aims
- To work with public bodies
- To influence policy which supports human rights.

The UK's Human Rights Act (HRA) sets out 16 key rights. BIHR exists to empower individuals and community groups trying to resolve a problem with a public authority, by supporting them in their use of a Human Rights approach. For example, a disability group in Wales challenged a decision that they felt was unfair citing Article 14 of the HRA and the decision was overturned.

Community groups can apply for grants to help them resolve issues with public bodies without recourse to a lawyer.
