Actions you can take this month:

- ✓ Join us on Thursday 13 February at 1430 at the Quaker Meeting House in Minehead for a talk on Pakistan and our Group AGM. Come and have your say about the future of the group.
- ✓ Send a message to the President of Egypt demanding the release of Oqba Hashad. In 2019, Oqba was wrongly arrested by Egypt's National Security Agency, simply because of his brother's human rights activism. While other students arrested alongside him were released, Oqba has been held in pre-trial detention for over five years, enduring unimaginable torture and denied essential medical care. His only crime is being related to someone who defends human rights. Despite a judge ordering his release, Egyptian prosecutors have kept him imprisoned. - Read Amnesty International's latest report 'You Feel Like You Are Subhuman': Israel's Genocide Against Palestinians in Gaza'. Campaign News

Cherry was listening to the BBC World Service recently. In a programme about prisoners released last August in the Russia prisoner swap, the husband of one of the journalists who had been held by the Russian authorities emphasised how much his wife had appreciated the cards sent by well-wishers. He urged everyone to send cards to political prisoners as they are a real morale boost, especially if cards are bright and colourful.

Write for Rights (WfR): We recently heard some good news about a prisoner we'd written about in a previous WfR campaign - Dorgelesse Nguessan had been released after more than four years of arbitrary detention for attending a peaceful protest in Douala, **Cameroon**. Sadly, 38 of the 500 originally arrested at the peaceful protest in September 2021, still remain wrongly imprisoned.



Other **good news** was that in early January five people were released after more than a year of arbitrary imprisonment for criticising the **Angolan** government. These critics included Ana da Silva Miguel also known as **Neth Nahara**, who was arrested in August 2023 after broadcasting a video on TikTok criticising President João Lourenço. Neth featured in the 2024 WfR campaign.



India Cherry writes:

BK16: very good news just out is that Rona Wilson and Sudhir Dhwale of the BK16 prisoners have been granted bail and were to be released. There are now only 6 of the original 16 in jail: Surendra Gadling, Mahesh Raut, Ramesh Gaichor, Sagar Gorkhe, Jyoti Jagtap and Hany Babu. Of course, being out on bail does not mean freedom, and there are strict conditions attached, but at least they will be more comfortable.



Fortieth anniversary of the Bhopal gas disaster and still no justice for victims: Forty years ago, in December 1984, a gas leak from a pesticide plant in Bhopal resulted in the deaths of at least **22,000 people**.



About 40 tonnes of lethal Methyl Isocyanate gas from the pesticide plant in Bhopal, then owned by US-based Union Carbide Corporation, quickly killed thousands of people living in informal housing around the plant. More have since died prematurely as a result of exposure to the gas, with deaths continuing to occur today. More than **500,000** were injured or have suffered permanent harm through the intergenerational impact of gas exposure on reproductive health, and through water sources contaminated by chemicals left on the site. Thousands of tonnes of toxic

waste remain buried in and around the abandoned plant, leading to increasing water pollution, clearly indicative of the area being considered a 'sacrifice zone' – an area so severely contaminated that it has demonstrable and devastating consequences on the health of local inhabitants and no effort is made to clean it up. Amnesty says that the woefully inadequate and callous response towards victims and survivors of the Bhopal tragedy has been enabled by **environmental racism**.

FIFA World Cup Qatar Legacy Fund: Al has criticised FIFA and Qatar over the launch of this fund because, although it will provide money to protect workers and refugees in the future, it does nothing to help the families of the vast number of migrant workers who were exploited and died to make the 2022 World Cup possible.

China: In January, Susan went to a showing of the film *All Static and Noise* at the Exeter Phoenix organised by the Exeter Group. It was a very powerful and moving film in which members of the Uyghur diaspora talk about the situation in Xinjiang and the families they have left behind. Do see it if you get the chance.

Guantanamo Bay: Abdulmalik Bajabu was released before Christmas, and another detainee, Khalid Qasim, has finally been released after spending 22 years imprisoned without charge or trial. More good news!
