### Egypt update from Margaret, our Campaign Co-ordinator

#### Alaa Abd el-Fattah

As you are already aware, the campaign in support of Alaa is reaching a critical and extremely worrying point. His family are clearly very concerned about the declining health of his 68-year-old mother, Laila, who has been on hunger strike for over three months. She has been joined in her hunger strike (for a limited time) by Peter Greste, an Australian former prisoner detained in Egypt alongside Alaa. They were desperately hoping that the Foreign Secretary, David Lammy's recent trip to Cairo might be an opportunity for him to press his case with President al-Sisi. However, although he spent time with his Egyptian counterpart, it does not seem as if he spoke with President al-Sisi himself nor that there has been any further progress on Alaa's case.

Further cause for concern is Alaa's own growing sense of despair, as revealed in intimate letters released by his family. In <u>an article</u> <u>by Patrick Wintour in The Guardian</u>, 30 January 2025, Alaa is reported to be contemplating renouncing his Egyptian and UK citizenship, since neither country has offered protection of his human rights. His desperate anxiety about his mother's fragile health is also evident in his letters.

Alaa now appears to believe that only direct intervention by Keir Starmer himself might produce results. However, he comments that, although Starmer raised the case of Jimmy Lai, (the detained Hong Kong activist), with the Chinese Premier, he has not so far spoken out openly on his own case.

### Action: Tunisia - Please take action on behalf of Human Rights Defender, Sihem Bensedrine

Human Rights Defender, **Sihem Bensedrine**, (aged 74), is currently on hunger strike in protest against the extension of her pre-trial detention on charges relating to her roles as President of the Truth and Dignity Commission. She is reportedly in very poor health.

Your Excellency,

I write to you to express my grave concern over the ongoing arbitrary detention of prominent 74-year-old human rights defender **Sihem Bensedrine** since her arrest on 1 August. On 14 January, she announced an open-ended hunger strike to protest her arbitrary detention.

Her lawyers shared this <u>message</u> in which she announced her hunger strike on her Facebook page: "I will no longer stand the injustice that strikes me. Justice cannot be based on lies and calamities, but on concrete, tangible evidence". She is detained solely in relation to her work as President of the Truth and Dignity Commission (IVD) from 2014 to 2018 which investigated and referred to the prosecution its findings on crimes committed by Tunisian authorities from 1955 to 2013.

Sihem Bensedrine has been under investigation since February 2023 following a complaint by a former IVD board member alleging forgery because revisions had been made to the IVD final report after it was submitted to the then president in December 2018. On 7 March 2023, an investigative judge charged Sihem Bensedrine with "forgery", "fraud" and "abuse of official capacity" and banned her from traveling. On 1 August 2024, the judge ordered Sihem Bensedrine's pre-trial detention and she was taken into custody on the same day. On 28 January 2024, the investigative judge informed her lawyers that he extended her pre-trial detention for another four months. Sihem Bensedrine's prosecution appears to be a form of reprisal against the work of the IVD exposing allegations of human rights abuses and corruption committed by past Tunisian authorities.

Since she started her hunger strike, **Sihem Bensedrine's** health has rapidly deteriorated. She is experiencing weakness and low oxygen levels, leading to her being placed under respiratory assistance in the prison infirmary. On 26 January, she was transferred to a hospital outside prison because her health deteriorated further. **Sihem Bensedrine's** pre-existing health conditions, including high blood pressure and cardiac issues, increase her vulnerability.

I urge you to immediately and unconditionally release **Sihem Bensedrine**, drop all the charges against her and end the misuse of the criminal justice system to target her. Pending her release, she must be granted adequate access to qualified health professionals providing health care in compliance with medical ethics, including the principles of confidentiality, autonomy and informed consent. Ensure she also has access to her family, lawyers and is held in conditions that comply with international standards.

**Manahel al-Otaibi** wrote tweets supporting women's rights. She also posted pictures of herself enjoying a day at a shopping mall. In the pictures, she is not wearing the abaya, a traditional robe, and these things alone were enough for the Saudi authorities to target her. She is currently serving an 11-year sentence for promoting women's rights and expressing herself on social media.

#### Good news!

Justice for Marielle: In 2018 we campaigned, as part of Write for Rights, for Marielle Franco's family. Marielle was a Brazilian activist who was fatally shot in a hit and run in 2018. For 6 years, the police investigation into Marielle's death was shrouded in secrecy. It was reported that the bullets that killed Marielle were from a batch bought by the federal police and, what's more, President Bolsonaro himself had been pictured with one of the murder suspects.



• You and thousands of others took action, and finally there has been a breakthrough in her case. In October 2024, 6 years after her death, Marielle's killers were sentenced to 59 and 78 years in prison.

**Neth is free:** We are delighted to share the news that Neth Nahara is finally free, after more than a year of arbitrary imprisonment. Neth was arrested on 13 August 2023 in her home in Luanda, Angola, simply for broadcasting a TikTok video criticising President Lourenço. During her time in custody, she was denied vital HIV medication, which caused her health to deteriorate significantly. Neth was later hospitalized due to the condition that worsened during her detention.



Last year, you joined thousands of others in demanding her release through **Write for Rights**2024, Amnesty International's biggest human rights campaign. Following this global campaign, Neth Nahara and four other Angolan activists were finally freed in the first week of January 2025.

**Dorgelesse has been released:** After more than four years of wrongful imprisonment for peacefully exercising her human rights, Dorgelesse Nguessan has finally been released. In September 2020, over 500 people, including Dorgelesse, were arrested for participating in protests in several cities across Cameroon. Having never been politically active before, Dorgelesse joined her first protest in Douala due to her growing concern about Cameroon's economy. Charged with "insurrection" and "public demonstrations" among other charges, she was then sentenced to five years in prison by a military court on December 7 2021.



 In 2022, you joined thousands of supporters in Amnesty's Write for Rights campaign, demanding her release. On 16/01/2025, she was finally released.
