

# Minutes of Amnesty International Reading Group Meeting

## Women's Rights in Afghanistan

Cherry gave us a talk about womens' rights in Afghanistan to deepen our understanding and support our chosen campaign this year. Cherry briefly covered the last 100 years of political history in Afghanistan, so we could appreciate how things are as they are now.

Key restrictions for women and girls, and their implications, include

- no education for girls beyond grade 6 this is the only country in the world to officially ban education
- virtually every sector of work is no allowed for women, including politics this situation is worsening by the day
- freedom of movement vastly restricted
- a formal dress code exists women are beaten in the street and arrested in they transgress
- forced and child marriages on are the rise, which is one of the reasons for increased maternal mortalities
- girls are being "sold off" as they are seen as a drain on the family, of no worth
- health care women can only be treated by women. The implications of stopping education for women will be catastrophic
- gender based violence has significantly increased
- freedom of expression has been severely hampered, particularly as female journalists are so restricted. Out of the house, women cannot raise their voices or be heard by others.
- the threat of arrests and torture prevail

- socialising women are not allowed to use the parks, the gyms, beauty salons, cannot wear perfume or shoes that make a noise
- in homes and building where women can be seen, windows are to be boarded up
- uniquely in Afghanistan, female suicide are higher than men and increasing
- families are leaving, particularly educated women
- if they manage to get to neighbouring countries, such as Pakistan, Iran or Tajikistan, they are treated very badly.
- if they have access to social media, this benefits women as they can communicate there is some education online but this is being clamped down when discovered
- Radio programmes are still going!

#### What can we do?

- continue to educate ourselves and others about the situation
- shine a light on the situation for Afghan women
- lobby other organisations, such as cricket, where the ICC are allowing the Afghan men's team to play, even though, under their own rules, all countries must have a women's team too.
- call on our leaders and world leaders to call the Taliban to account for their treatment of women and girls

#### • 50th Birthday party review

#### • feedback from the Amnesty Feminist conference

Ilaria and Helen had attended the Amnesty Feminist conference last weekend. Iliaria reported that we were treated very well, good amount of breaks, food & snacks and freebies. The business of the day was excellent, with excellent panels and workshops to support campaigning. One helpful session was from the <u>Joyful Activists</u>, who shared ideas to prevent activism burn-out.

One grassroots campaign presentation was by a group called <u>Make it Mandatory</u> -They are passionate about Relationships and Sex Education being extended beyond 16, so Key Stage 5 pupils continue to have access to prevent violence and abuse against women. <u>please sign their petition here</u>

#### • sponsored Human Rights Trail

Iona and Helen shared more details and plans for the sponsored Human Rights trail. Proposals include

- use trybooking so we can limit numbers to 20, which is safe for an outside walk
- entry fee of £10 which will come to the group

- use just giving to create a team page and encourage all walkers to raise sponsorship money - this to go to Amnesty's Charitable section so gift aid of 25% can be collected
- Walk to be in central/city of London, and will have several stops linked to key campaigns
- start and finish near cafes, etc
- usual mention of need to change date if weather/circumstances make it too risky we have been in touch with Amnesty to check risk assessments, etc
- date Sunday 14th September from 2.30pm it will be about 2 hours
- script could be shared with other groups
  group approved these arrangements, so more planning will occur!

### **Group campaign updates**

#### Anti-death Penalty

 Good news - We are relieved to receive the news that Alabama Governor Kay Ivey has commuted Rocky Myers' death sentence, preventing his imminent execution. However, Rocky's fight for justice is far from over, he now faces life without the possibility of parole despite serious flaws in his case. Amnesty International has long supported Rocky, with thousands of activists worldwide taking action through petitions, letters, and calls as part of the Write for Rights campaign in 2023. While this commutation is a crucial step, Amnesty continues to call for a full review of his case and justice for others sentenced through the now outlawed judicial override system.

- UAE our prisoners of conscience, Ahmed Mansoor & Dr Mohammed al-Roken
  - During a hearing on 04 March 2025, the State Security Department of the Federal Supreme Court in the United Arab Emirates (UAE) rejected the appeals submitted by 53 people convicted in the case known in the media as the "UAE84" case. They include Ahmed Mansoor, who is on the Advisory Board of the Gulf Centre for Human Rights (GCHR).
  - 20th March is the anniversary of Ahmed's arrest, so the group will be putting together a photo action to release on our socials on 20th, calling for his freedom
