ELECTION CANDIDATES SUPPORT HUMAN RIGHTS

DURING THE 2011 Scottish Parliament election campaign Amnesty International asked candidates to show their support for human rights by having their photo taken with an Amnesty placard or poster stating 'Scotland Stands for Human Rights'.

This relatively modest request reflects Amnesty concerns that while most people in Scotland will readily agree that respect for human rights is an urgent demand in Libya, China and Guatemala, talk of human rights in Scotland is often skewed by populist outrage suggesting a cushy life for rapists and murderers in jail.

Amnesty Scotland campaigner, Julie Hepburn, said 'Rather than publish an ambitious manifesto of political demands we decided to ask candidates simply to affirm their support for human rights. The response has been fantastic and we are looking forward to engaging the new body of MSPs on the basis that we all support human rights and the focus now must be on implementing that vision here in Scotland.'

As we go to press 180 candidates have taken the pledge and, barring any major surprises, we can be fairly certain that a clear majority of the 129 MSPs elected in May will have signed up in support of human rights.

LOOKING AHEAD

AMNESTY INTERNATIONAL has some specific human rights issues which it wants the next session of the Scottish Parliament to address. These are some of the issues we will be pursuing with the new intake of MSPs:

- The Scottish Government must take a leading role on Scottish Gypsy Travellers (page 2).
- Scotland must promote a dialogue on human rights issues in all international relations. The Scottish Government's engagement strategy already contains an explicit commitment to raising human rights with China, but rather than single out one country human rights should extend throughout all engagement, with India, the USA and others. Of course these countries may well have issues to raise with us too.
- The Equal Opportunities Committee of the Parliament should have its remit extended to allow investigation of human rights issues in Scotland. Currently consideration of human rights is limited to a very occasional mention by the Justice Committee.
- The opportunity for children to learn about their human rights is a right in itself. Appropriate support for human rights education will ensure that more Scottish children can learn respect for themselves and for others.

NEWS REVIEW

CALL FOR GOVERNMENT LEAD ON SCOTTISH GYPSY TRAVELLERS

AMNESTY INTERNATIONAL is calling on the new Scottish Government to take a leading role in addressing prejudice against Scottish Gypsy Travellers and reducing tensions between settled and Traveller communities.

Studies have repeatedly raised fundamental human rights concerns over the situation of Scottish Gypsy Travellers – particularly the rights to health, education, housing, family life and cultural life, and the requirement to be free from discrimination in the realisation of these rights.

The Traveller way of life is under increasing pressure, with the number of suitable stopping places in Scotland continually diminishing. The resulting growth in illegal camping, combined with hostile reporting in local media, is fuelling resentment against Travellers and increasing tension between settled and Traveller communities, from which nobody benefits.

Amnesty Scottish programme director, John Watson, commented 'All of the necessary principles, statements and duties on race equality and discrimination already exist. What we need now is for the government to take a leading role in implementation, exerting political pressure to make sure that all the fine words translate into real action.'

Amnesty International has started the discussion with a list of suggestions for what this political role might entail, which is available on our website.

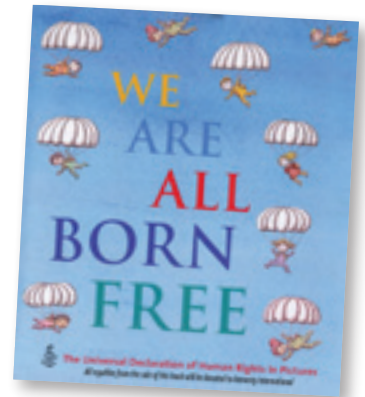
EDUCATION WEST END FESTIVAL

GYPSY TRAVELLERS UPDATE

DELEGATION HIGHLIGHTS DISCRIMINATION ACROSS EUROPE

IN FEBRUARY Amnesty International led a delegation of concerned organisations, including church, trade union and Traveller groups, around various European consulates in Edinburgh. To highlight the widespread nature of discrimination across Europe the delegation delivered letters of concern specific to the situation in each individual country, ending with the presentation of a letter of concern about Scottish Gypsy Travellers to Bute House, official residence of the First Minister.

The event generated some positive media coverage and some consulate representatives were willing to talk to us. We are waiting for official responses from the others but in the meantime the letters can be viewed on our website.

CONCERNS OVER TASER PILOT MUST BE ADDRESSED

FOLLOWING THE end of the Strathclyde Police pilot issuing Taser electro-shock weapons to ordinary officers on the beat, Amnesty International has produced a summary of outstanding concerns over the pilot. We have called for assurances that there will be no further distribution of Tasers until these concerns have been properly addressed.

Amnesty International believes

that Tasers are inherently dangerous weapons that should be limited to specially trained firearms officers. Yet much of the recent campaign centred on the fundamental question of whether the Scottish police use of firearms is subject to any democratic scrutiny and control.

Our summary sets out clearly that police should be politically accountable for their deployment of

Tasers and explains how they do this elsewhere in the UK. Given all the problems associated with the pilot there should be no more attempts to normalise these dangerous weapons on Scottish streets.

In each case we will be engaging authors appearing at the festivals to stand in solidarity with persecuted writers by reading excerpts from their work.

NEW FUNDING GIVES BOOST TO ANTI-VIOLENCE PROJECT

WHITE RIBBON Scotland, of which Amnesty International is a supporting organisation, has been awarded ongoing funding from the Scottish Government. White Ribbon Scotland engages men in Scotland in tackling violence against women. Our support for this new campaign

is a central part of our follow-up to the Stop Violence Against Women work. Over 1,000 people have now signed the White Ribbon pledge 'not to commit, condone or remain silent about violence against women' and the new funding announcement represents

a huge step towards White Ribbon Scotland becoming a sustainable part of Scottish public life.

REACHING OUT

His case was highlighted during the 2009 Edinburgh Festival with thousands of Scots pledging their support for the Indian doctor and demanding all charges against him be dropped. A mosaic of his image constructed from their signatures was handed over to the Indian Consul General, Mr Anil Kumar Anan.

Amnesty Scotland campaigner, Siobhan Reardon, said: 'The support which Binayak Sen has received from the people of Scotland is a recognition of his human rights work and his courage to speak out against the atrocities committed against his people. The thousands of signatures which Amnesty has received in support of Dr Sen are testament to the deep-rooted sense of justice which exists amongst Scots.'

PRESSURE ON INDIA CONTINUES FOR RELEASE OF BINAYAK SEN

ON 19 JANUARY, Amnesty International handed over thousands of signatures demanding justice for jailed Indian doctor Binayak Sen.

Dr Sen was handed a life sentence on Christmas Eve last year after being charged with sedition and conspiracy, charges which Amnesty believes are politically motivated and aimed at stopping his human rights work.
