## AIUK BOARD ELECTION: 2012

### Nominations.

The Country Co-ordinator seat, a network forum seat, a local groups seat and one unreserved seat were available for election this year. Five candidates were nominated. One candidate was nominated for the Country Co-ordinator seat and one for the network forums seat and consequently Rona Keen and Tom Hedley were elected unopposed to the Board. Subsequently an election was required for the local groups seat and unreserved seat.

The preparations for the contest went fairly smoothly thanks to HQ staff at Amnesty and the cooperative assistance of Tom Colling of ERS and with only a couple of minor hiccups.

#### **Election Result.**

As reported above Rona Keen was elected unopposed to the Country Co-ordinator seat and Tom Hedley was elected unopposed to the network forum seat. Katie McSherry was elected at stage 1 as she exceeded the quota of 4786 votes required to be elected. The contest went to the 2nd stage at which point Hugh Whitby was beyond the reach of the remaining candidate and was thus duly elected for the final place. As both candidates had stood for either of the available seats it was agreed that Katie McSherry would take the local groups seat and Hugh Whitby the unreserved seat.

## **Voting Turnout.**

Although the number of ballot papers issued this year was down –122,398 as against 129,479 in 2011- the turnout was an improvement at 11.17%. In 2011 the percentage turnout was.8% and 5.8% in 2010. The number of youth and student groups voting remains a challenge. The increase in individual votes might be attributed to the use of social media by candidates but there might also be other reasons. The small increase in the votes of local groups hopefully reflects the attempts to raise awareness amongst the groups.

± This is the total number of votes cast. The total weighted votes cast was 14,409. There were 51 votes found to be invalid. This gave the total valid weighted votes of 14,358.

Note: The quota for electing the two candidates under the STV system is calculated as the valid weighted votes of 14,358 divided by the number of places to be filled plus one (2+1=3) giving a quota of 4786.

## **How Votes Were Distributed Amongst the Candidates**

Previously I was asked to provide information on how votes were distributed amongst the candidates and the figures below give the breakdown of this year's election. It should be noted that the figures refer to first preference votes for the respective candidates.

## **Election Pamphlet.**

On the whole the election documentation appears to have worked reasonably well. The previously mentioned errors had no impact on the election which saw an increased turnout. There was, however, an increase in the number of spoilt ballot papers – 51 as against 41 in 2011 – and it would appear that this is a continuing trend as last year's figure was an increase on 2010. .Some work needs to be undertaken to see if we can determine the nature of this trend; please see concluding remarks.

#### Automatic Retirements in 2013.

The Board members who automatically retire next year are Collette Anne Crill, Sharmila Kar, Brian Landers, Peter James Murray and Sarah O'Grady.

Collette and Sarah are eligible to stand again for a further three years but the six consecutive years rule applies to Sharmila and Peter. Sharmila and Peter will need to have a sabbatical of at least nine months before they can stand again for the Board. Brian is co-opted as Treasurer and a further period of office is a matter for the Board.

## **Concluding Remarks**

Concerns were raised about the errors in the ballot papers. After investigating the impact of these errors it appears clear that they had little or no impact on the effectiveness or outcome of the election. Nevertheless any errors need to be avoided and measures will be put in place to prevent any further occurrence as far as this is possible. The timetable for ballot preparation is always short but it is possible to expand preparation time by commencing the process as soon as it is clear that an election is required rather than waiting until the closing date for nominations. There are also a number of tasks that can be undertaken before close of nominations which would allow for a longer period of preparation. Work to effect these improvements will be incorporated into the Board Ballot Project Plan for next year's election. The Plan will be drawn up in the period up to September 2012.

Part of the Project Plan will incorporate work on investigating the slowly increasing numbers of spoilt papers mentioned above. The problem may lay with the wording of the instructions on how to vote or there might be other reasons. Any lessons learnt will be incorporated into the preparations for next year's ballot.

Some work will also be undertaken on the issue of the election turnout. A comparison with other similar organisations will be attempted and some thoughts given to addressing the low turnouts from student and youth groups. There was a noticeable use of social media in this year's election for raising awareness of the candidates which might have had some impact on turnout although this would not be easy to establish. It is likely that the use of social media will increase in future elections.

I can report that the number of members using the facility to vote at the AGM remains very small. Voting by post remains the dominant form of voting followed by on-line voting while the use of the telephone facility remains low. The services provided by ERS (Electoral Reform Services) remain excellent but the Board might like to consider whether it is time to re-tender for future elections. However, recognising that the passing of Resolution C2 AIUK Legal and Taxation Structure might have some impact on future governance arrangements including the election of the Board any changes might be more appropriate after decisions have been taken on future arrangements.

In conclusion can I again thank everybody who assisted in this year's election process; without them my task would have been impossible.
